Local Non-profits do not have to pay for booth space. Please provide your 501C3 when making application to have the \$50. Booth rental fee waived.

Electricity will be provided for a \$30. Fee Per booth.

Water is available for Food Booths.

Application is a commitment to be present at the Festival. Please no open flames and Alcoholic beverages will be permitted at the booths. Food Booths will be have official inspection at 9:00 am on September 30, please have your booth set up and ready for inspection.. If you are cooking your tent must have a fire rated tent. You may cook outside of the tent with a 5-6' space from the tent. You may have heated food under the tent. If purchased electricity all extension cords will be UL approved. No frayed/spliced or damaged cords allowed. No crossing streets or sidewalks so as not to cause a trip hazard. SAFETY FIRST.

Saturday September 30 8am-10am

Saturday September 30 10am-5pm Vendors on 3<sup>rd</sup> Street Block will need to be open during the Block Party which will be 7pm-9:30pm

Sunday October 1 10am-5pm (Time determined closer to Frolic start based on the number of vendors)
