

St. Johns River Bartram Frolic 2018 Arts and Crafts Vendor Application

This agreement is between _____ and the
Putnam Blueways and Trails/Bartram Committee.

There will be no Buy/Sell, flea market or imported items for the frolics. Work displayed must be your own and the artist/crafter must be present. If you do not make the items, then you are not allowed to display them or sell them. The Frolics committee will determine the eligibility to exhibit and sell during the Frolics. Should a vendor be accepted as a result of misleading information or an oversight during the approval process, they will not be allowed to participate.

The committee may limit the number of artisans based on category so that everyone has an opportunity to make money.

Please submit your signed agreement, payment and photos of your work to be sold, so that the committee may review your application for acceptance. Please make sure what you submit in photos is what you will be displaying and selling. Use back of application to describe your work and techniques. You may not sell items other than those approved in advance.

Craft Vendor spaces are 10'x10'.

Hours for Vendors are as follow:
Set up is Friday September 28 5pm-8pm
Set Up Saturday September 29 8am-10am
Vendor Frolic Hours Saturday September 29 10am-5pm

Equipment teardown may only occur after 5:00 pm on September 29, 2018. Everything must be removed by 9pm. No early teardowns. No vehicles will be allowed on Memorial Parkway and St. Johns Ave. until after 5:00pm. You are responsible for leaving your space clean including removal of trash or other debris. All trash must be placed in dumpsters.

Artist and Crafter Vendor fee is \$50. Per space. Application deadline is September 1, 2018. Full payment and contract must receive by this date.

Fees are non refundable once the Frolic accepts you as vendor. Vendor will be notified by email when accepted. Any vendor not accepted will be notified by email and your check will be returned. Once a complete application has been submitted it will be processed.

There are limited spaces for electricity. You must request it in advance and there will be an additional fee of \$30. per space for basic electricity. Generators are not permitted. Cords must not cross sidewalks or streets. You are responsible for your own extension cords. They must be in good working order. If purchased electricity all extension cords will be UL approved. No frayed/spliced or damaged cords allowed. SAFETY FIRST.

Application is a commitment to be present at the Frolics. Please no Fires or Alcoholic beverages will be permitted at the booths.

Your entire display must fit inside your assigned space. You may not extend past the approved designated space. Your space will be clearly marked on all 4 sides.

You are responsible for collecting any Florida State Sales and Use Tax. Vendor must provide their own liability insurance and include a copy of the policy.

Please do not attempt to sell anything that does not have prior approval. If you do so you will be asked to leave. We reserve the right to cancel and have you leave the festival if you are disruptive or are a fraudulent exhibitor.

This contract is not transferrable.
